Dear Governor O'Malley, Speaker Busch and President Miller:

As Dr. Martin Luther King, Jr. said, "The time is always right to do what is right." And the time is both right and ripe for a Special Session to be held without delay.

We are members and leaders of Maryland's faith community. We join together to urge a quickly convened Special Session to undo the "Doomsday Budget" because we are all too acquainted with the pressing, sometimes desperate needs of our congregants and the communities in which we serve. Revisiting and correcting what was left undone on April 9 is an imperative moral issue.

The Doomsday Budget would strip more than \$128 million from K-12 Education funding, and impose cuts to higher education. That translates into greater class sizes, fewer programs, and higher tuitions. More than 500 state jobs are in jeopardy, and \$150 million in cuts to state agencies are planned. These are larger cuts than the General Assembly's budget committees were able to identify in ten weeks of detailed analysis and hearings. Public safety, health, and general welfare are all touched. Even before these additional losses, the ranks of our state employees are so thin that in recent years we have not had sufficient state personnel to process emergency cash assistance requests, leading to a lawsuit against the state, and we have seen caseloads balloon to unmanageable proportions in such critical areas as probation and parole, mental health facilities and emergency services. In Maryland, the country's wealthiest state, this is intolerable.

Additionally, because the revenue package and the Budget Reconciliation and Financing Act (BRFA) did not pass in the waning hours of session, a number of very important measures, such as the increased tax for smokeless (chew and spit) tobacco and little cigars, fell as well. This failure compromises our children's well-being and very lives. The evidence is clear: raising cigarette taxes over the past 10 years has discouraged youth smoking of cigarettes, and saved about 70,000 lives. At the same time youth use of little cigars and smokeless tobacco has gone up. By raising the tax on

little cigars to 70%, and on smokeless tobacco to 30%, we can save thousands of young Marylanders from addiction to these deadly products.

We understand and believe that the Doomsday budget's harsh results were not intended, and that Senate and House conferees agreed to a budget agreement with sufficient revenue to avoid these cuts before Sine Die. Although we cannot turn back the clock, we can ask that such an agreement be enacted as soon as possible. There is no time to waste. We must do right for the least among us, and for all our fellow citizens.

We thank you for all the good you have done for Maryland, in this session and in sessions past. We ask you to avert "Doomsday," a condition that we never would wish to bring upon our state.
