CHAPTER _____

1 AN ACT concerning

2 **Public Health – Prescription Drug Affordability Board and Fund**

3 FOR the purpose of repealing certain provisions of law requiring the Prescription Drug
4 Affordability Board to determine a certain funding source on or before a certain date,
5 consider using certain methods in making a certain determination, and report to
6 certain committees of the General Assembly on a certain recommendation; requiring
7 the Board to assess and collect a certain fee from certain persons in a certain manner;
8 requiring the Board to calculate a certain fee in a certain manner; requiring certain
9 entities to pay a certain fee on or before a certain date each year; requiring the Board
10 to allow certain persons to make certain payments; providing that certain fees may
11 be subject to a certain interest penalty; prohibiting a certain amount of fees collected
12 within a certain period of time from exceeding a certain amount; requiring the Board
13 to pay certain fees into the Prescription Drug Affordability Fund; establishing the
14 Fund as a special, nonlapsing fund; specifying the purpose of the Fund; requiring the
15 Board to administer the Fund; requiring the State Treasurer to hold the Fund and
16 the Comptroller to account for the Fund; requiring any interest earnings of the Fund
17 to be credited to the Fund; specifying the contents of the Fund; specifying the purpose
18 for which the Fund may be used; providing for the investment of money in and
19 expenditures from the Fund; requiring the Fund to be subject to a certain audit;
20 adding special funds to the types of funds that are required to be used to establish
21 the Board; requiring the Board to repay certain funds from the Fund to the Maryland
22 Health Care Commission under certain circumstances and over a certain period of
23 time; exempting the Fund from a certain provision of law requiring interest earnings
24 on State money to accrue to the General Fund of the State; providing for the
25 construction of certain provisions of this Act; defining a certain term; making

38 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
39 That the Laws of Maryland read as follows:

1 (II) PHARMACY BENEFITS MANAGERS, AS DEFINED IN §
2 15-1601 OF THE INSURANCE ARTICLE;

3 (III) CARRIERS, AS DEFINED IN § 19-132 OF THIS ARTICLE; AND

4 (IV) WHOLESALE DISTRIBUTORS, AS DEFINED IN § 12-6C-01 OF
5 THE HEALTH OCCUPATIONS ARTICLE; ~~AND~~, THAT SELL OR OFFER FOR SALE
6 PRESCRIPTION DRUG PRODUCTS TO PERSONS IN THE STATE.

7 ~~(V) ANY OTHER ENTITY IDENTIFIED IN REGULATIONS ADOPTED~~
8 ~~BY THE BOARD.~~

9 (2) THE BOARD SHALL:

10 (I) ASSESS AND COLLECT THE ANNUAL FEE UNDER
11 PARAGRAPH (1) OF THIS SUBSECTION IN ACCORDANCE WITH CRITERIA
12 ESTABLISHED IN REGULATIONS ADOPTED BY THE BOARD; AND

13 (II) CALCULATE THE ANNUAL FEE UNDER PARAGRAPH (1) OF
14 THIS SUBSECTION IN A FAIR AND EQUITABLE MANNER.

15 (3) (I) ON OR BEFORE OCTOBER 1 EACH YEAR, EACH ENTITY
16 ASSESSED A FEE UNDER THIS SUBSECTION SHALL PAY THE FEE ASSESSED BY THE
17 BOARD.

18 (II) THE BOARD SHALL ALLOW ENTITIES TO MAKE PARTIAL
19 PAYMENTS WHEN PAYING THE FEE ASSESSED UNDER THIS SUBSECTION.

20 (III) ANY FEE NOT PAID WITHIN 30 DAYS AFTER THE PAYMENT
21 DUE DATE MAY BE SUBJECT TO AN INTEREST PENALTY TO BE DETERMINED AND
22 COLLECTED BY THE BOARD.

23 (4) THE TOTAL AMOUNT OF FEES THAT THE BOARD COLLECTS IN
24 EACH CALENDAR YEAR UNDER PARAGRAPH (1) OF THIS SUBSECTION MAY NOT
25 EXCEED \$2,000,000.

26 (5) THE BOARD SHALL PAY ALL FEES COLLECTED UNDER
27 PARAGRAPH (1) OF THIS SUBSECTION INTO THE FUND.

28 (C) (1) THERE IS A PRESCRIPTION DRUG AFFORDABILITY FUND.

29 (2) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING FOR THE
30 BOARD AND TO CARRY OUT THE PURPOSE OF THIS SUBTITLE.

1 **(3) THE BOARD SHALL ADMINISTER THE FUND.**

2 **(4) (I) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT**
3 **SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

4 **(II) THE STATE TREASURER SHALL HOLD THE FUND**
5 **SEPARATELY, AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.**

6 **(5) THE FUND CONSISTS OF:**

7 **(I) REVENUE DISTRIBUTED TO THE FUND UNDER SUBSECTION**
8 **(B) OF THIS SECTION;**

9 **(II) MONEY APPROPRIATED IN THE STATE BUDGET TO THE**
10 **FUND;**

11 **(III) INTEREST EARNINGS; AND**

12 **(IV) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED**
13 **FOR THE BENEFIT OF THE FUND.**

14 **(6) THE FUND MAY BE USED ONLY TO PROVIDE FUNDING FOR THE**
15 **BOARD AND FOR THE PURPOSES AUTHORIZED UNDER THIS SUBTITLE, INCLUDING**
16 **ADMINISTRATIVE EXPENSES AND ANY COSTS EXPENDED BY ANY STATE AGENCY TO**
17 **IMPLEMENT THIS SUBTITLE.**

18 **(7) (I) THE STATE TREASURER SHALL INVEST THE MONEY OF THE**
19 **FUND IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.**

20 **(II) ANY INTEREST EARNINGS OF THE FUND SHALL BE**
21 **CREDITED TO THE FUND.**

22 **(8) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN**
23 **ACCORDANCE WITH THE STATE BUDGET.**

24 **(9) THE FUND IS SUBJECT TO AUDIT BY THE OFFICE OF LEGISLATIVE**
25 **AUDITS AS PROVIDED FOR UNDER § 2-1220 OF THE STATE GOVERNMENT ARTICLE.**

26 **(10) THIS SUBSECTION MAY NOT BE CONSTRUED TO PROHIBIT THE**
27 **FUND FROM RECEIVING FUNDS FROM ANY OTHER SOURCE.**

28 **(d) (1) The Board shall be established using SPECIAL OR general funds, which**
29 **shall be repaid to the State with the funds from the [funding source determined by the**
30 **Board under subsection (a) of this section] FUND.**

8 (a) (2) (i) Notwithstanding any other provision of law, and unless
9 inconsistent with a federal law, grant agreement, or other federal requirement or with the
10 terms of a gift or settlement agreement, net interest on all State money allocated by the
11 State Treasurer under this section to special funds or accounts, and otherwise entitled to
12 receive interest earnings, as accounted for by the Comptroller, shall accrue to the General
13 Fund of the State.

14 (ii) The provisions of subparagraph (i) of this paragraph do not apply
15 to the following funds:

16 121. the Markell Hendricks Youth Crime Prevention and
17 Diversion Parole Fund; [and]

18 122. the Federal Government Shutdown Employee Assistance
19 Loan Fund; AND
